Submission of Entries

- All members are welcome to submit one painting for this exhibit. **If you are submitting to this exhibit, please send a confirmation email to bzgriff53@gmail.com to secure your spot in the show as space is limited. The first 50 responders to this prospectus (by email to bzgriff53@gmail.com ONLY) will hang in this exhibit.**
- Maximum image size is 20 inches in either direction.
- All work is to be completed in plein air and framed in a professional manner. Work is to be original and executed by the artist. Specific hanging requirements are attached. ONLY the "D" ring hangers are accepted by this gallery as the paintings are hung on a double cable system.
- All mediums welcome (oil, pastel, acrylic, pencil, charcoal, watercolor).
- **This is an exhibition for current, paid PAPI members only.**

Eligible Work

- The work is to be plein air in nature since that is the focus of the PAPI.
- All work should be original in concept and executed by the artist. Artists must be an active member of the PAPI & at least 18 years old.

Liability

- All reasonable care will be taken with submissions.
- Please note that PAPI, its officers, volunteers and Initial Point Gallery and City of Meridian shall not be held responsible for the loss and/or damage to painting or frames.
- PAPI suggests that participants carry separate insurance on their work.
- The artist grants permission to reproduce work for publicity purposes, both in print and digital galleries. Copyright will be attributed to the artist.
- Entry into this exhibition constitutes agreement with all conditions set forth in this prospectus/ Entry Form, and is your commitment to participate. Your entry form is a legal and binding contract to deliver artwork that has been entered into the show. The Acceptance Agreement from the Initial Point Gallery is in a separate attachment and should be reviewed by the artists participating, as this agreement is the contract between Plein Air Painters of Idaho and the IPG of the City of Meridian.

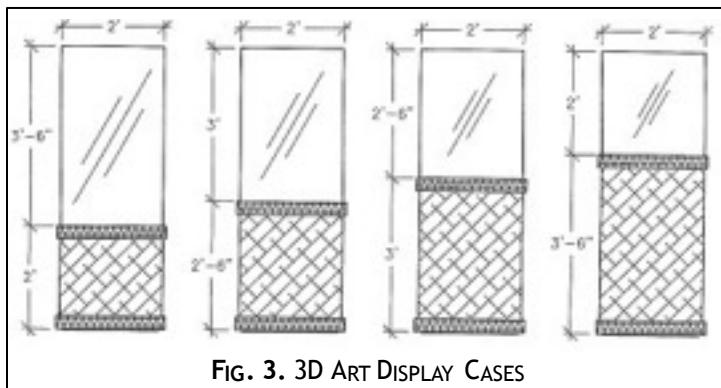
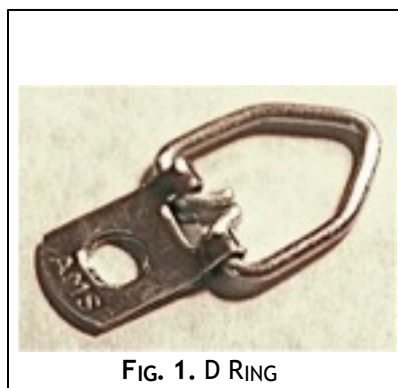

DISPLAY INFORMATION:

Initial Point Gallery is equipped with a track system for hanging two-dimensional artwork. Two-dimensional artwork will be hung from cables, using hooks, and therefore must be equipped with two D rings (fig. 1) on the side rails on the back of the frame (fig. 2). The inside of each D ring must allow a space of at least one-quarter inch ($\frac{1}{4}$ ") for insertion of the hooks; any wire constricting this space must be removed. The D rings should be approximately a quarter of the distance of the total frame height from the top of the frame in order to avoid slanting away from the wall. Wires, eyehooks, and clip frames may not be used for hanging. Initial Point Gallery also provides four display cases, each with different dimensions (fig. 3), for displaying three-dimensional artwork.



The acceptance agreement to display work at the Initial Point Gallery is sent as an additional attachment to this call to artists.
